Position Expectations

Working at the Folsom Winter Ice Rink is fun, rewarding, and unlike any other seasonal job—but it is also a physically active, hands-on position that requires every team member to pitch in wherever needed.

Crew Members are cross-trained in all areas of rink operations, including:

- Guest services and ticket sales
- Skate rentals
- Concession service
- On-ice skate guarding
- Assisting guests of all ages

In addition to these responsibilities, this position also includes the behind-the-scenes work that keeps the rink clean, safe, and operating smoothly. All Crew Members should expect to:

- Shovel snow and ice around the rink and Zamboni area after sessions
- Empty trash and keep the facility clean throughout the day
- Clean and restock restrooms
- Sweep, mop, wipe down surfaces, and maintain work areas
- Set up and break down equipment as needed
- Work outdoors in cold, wet, and sometimes challenging weather conditions
- Lift, carry, push, and move equipment and supplies
- Jump in wherever help is needed, even if it's outside your assigned station

No task is considered "someone else's job." Every member of our team—from seasonal staff to management—works together to create a safe, clean, and memorable experience for our guests.

We are looking for applicants who are dependable, hardworking, positive, flexible, and willing to roll up their sleeves when the job calls for it. If you're excited to work hard, support your teammates, and help create holiday magic for thousands of guests, we'd love to have you join our team.
